- ➤ Clay County Senior Services has a *Caregiver Directed Respite Program*. Full-time primary caregiver must live in the home with the care recipient. You choose your own respite worker and get reimbursed for up to 6 hours per week. Call 816-455-4800 for income guidelines.
- Check eligibility for in-home services, food stamps, or MO Health Net by calling Department of Health & Senior Services at 855-373-4636. Automated line to check status: 1-800-392-1261. You can also download an application (health.mo.gov/seniors) or actually go to the Medicaid office at 7000 Liberty Drive in Liberty. Income and asset restrictions apply.
- ➤ Inquire about programs & services through MARC Aging & Adult Services: care management, caregiver support, in-home services, transportation, and more. 816-421-4980; marc.org.
- ➤ To find out if you can get paid as a <u>family caregiver</u> (Consumer Directed Service through Medicaid), contact Dept. of Health & Senior Services at 855-373-4636.
